

## Adult Members Garda Vetting Forms (Age 18+)


Current adult members of the Irish Red Cross who are submitting a Garda Vetting application must complete the below forms:



#### Form 1 – ID Verification Form:

As part of the Garda Vetting process, applicants must provide documentation to validate their identity.

The ID Verification form must be signed off by the local Irish Red Cross Branch you are joining. The form must be signed by the Branch Secretary, Treasurer, Chair, or Vice-Chair within the Branch.



## Form 2 – Adult E-Vetting Invitation Form:

This form requires your current address and an email address.

We submit your E-Vetting Invitation to the National Vetting Bureau. They then send you an e-mail containing a link that allows you to complete your Garda Vetting application online.



## IRISH RED CROSS PROOF OF IDENTIFICATION FOR GARDA VETTING

Before we can process your Garda Vetting Form, it is a Garda Vetting requirement that you complete an Identification Check.

# **Guidelines for completing Vetting Invitation Form (NVB 1)**

Please read the following guidelines before completing this form.

#### Miscellaneous

The Form must be completed in full using **BLOCK CAPITALS** and writing must be clear and legible.

The Form should be completed in ball point pen.

Photocopies will not be accepted.

All applicants will be required to provide documents to validate their identity.

If the applicant is under 18 years of age, a completed NVB 3 - Parent\Guardian Consent Form will be required. Please note that where the applicant is under 18 years of age the electronic correspondence will issue to the Parent\Guardian. This being the case, the applicant must provide their Parent\Guardian Email address on the NVB 1 form.

#### **Personal Details**

Insert details for each field, allowing one block letter per box.

For Date of Birth field, allow one digit per box.

Please fill in your Email Address, allowing one character/symbol per box. This is required as the invitation to the e-vetting website will be sent to this address.

Please allow one digit per box for your contact number.

The Current Address means the address you are now living at.

The address fields should be completed in full, including Eircode/Postcode. No abbreviations.

### **Role Being Vetted For**

The role being applied for must be clearly stated. Generic terms such as "Volunteer" will not suffice.

#### **Declaration of Application**

The applicant must confirm their understanding and acceptance of the two statements by signing the application form at Section 2 and ticking the box provided.
