

I understand the following:

- This certificate is valid for the above tax year and each of the four following tax years, unless I notify the approved body of its cancellation.
- The approved body may apply to the Revenue Commissioners for tax relief in respect of my donations to me, or to any other approved body.
- I grant permission to the approved body to use my PPSN for the purpose of claiming tax relief on my donations during the lifetime of this enduring certificate or a renewed enduring certificate.
- I must advise the approved body immediately of any change in my circumstances that would affect the me, or to any other approved body.
- I must be resident in the State for each tax year in which I make a donation.
- A donation, or donations, must amount in aggregate to at least €250 in a tax year and be in the form of money and / or designated securities and that tax relief will not apply to the aggregate of my donations to an approved body or bodies in a tax year in excess of €1,000,000.
- Neither I nor any person connected with me, can receive a benefit from the approved body in consequence of making a donation.
- A donation cannot be subject to a condition as to repayment nor can it be conditional on, or associated with, the acquisition of property by the approved body other than by way of gift, from me or a person connected with me.
- The amount of my aggregate annual donations to an approved body (or bodies) with which I am associated (see Notes) will be restricted to an amount equal to 10% of my total income for the tax year in question and tax relief will not apply to any donations in excess of that amount.

INDONESIA

Indonesia has become the region's epicentre with more new cases being reported each day, on average, than in India. Red Cross ambulance services have helped more than 2,055 people. And nearly 2 million have accessed health services through the Red Cross with clinics across the country.



INDIA

In India, a high tuberculosis rate creates a greater COVID-19 risk. The symptoms are similar, often affecting the lungs. Many people with TB live in crowded areas, increasing the danger of COVID-19 infection.

Volunteer groups have been active across India. They share hygiene information, disinfection activities, and health surveillance. And in Jalandhar, Punjab, Red Cross volunteers are working around the clock to provide food to the most vulnerable.



NEPAL

In Nepal, an emergency blood transfusion service and an eye-care service have been created. Communities have received tents and tarpaulins to create help desks. Two ambulances are also on standby in the Myagdi District, ready to bring patients to major hospitals.

COVID-19 intervention is now part of our Community Livelihood Programme. We have distributed masks, soap, and hand sanitiser to 415 households in Begkhola village.



PHILLIPINES


We've scaled up our COVID-19 response through a wide network of branches and volunteers. To support the healthcare system, we are distributing surgical masks and personal protective equipment. We are also setting up medical tents. These tents serve as medical units when hospitals with COVID-19 patients are full.

In Beirut...

How you continue to help, one year on

Beirut is suffering. The economic crisis has devalued Lebanon's currency. Last year's port explosion demolished lives as well as buildings. Lebanon has the highest per capita share of refugees in the world. And they are fighting a COVID-19 surge since January.

The priority now is sustaining Lebanon's health services. The most pressing demand is for ambulance services and blood transfusions.

COVID-19 operations focus on helping people recover from the virus. The country is in the midst of one of the region's worst outbreaks. And last month, a vaccine marathon had to be postponed due to electricity outages.

Hospitals are bursting with COVID-19 patients. So the Lebanese Red Cross launched an initiative to deliver oxygen machines. Red Cross hotlines still receive more than 4,000 calls each day. Almost all are about COVID-19 patients.

Many families in Lebanon are still struggling. The Red Cross has responded with direct financial aid in US dollars, since the local currency has lost its value.

People around the world, through the International Federation of Red Cross and Red Crescent Societies (IFRC) have come to the aid of the people of Lebanon.

With your generous support, you are part of this movement as well. Because you care about people – whether they are down your street or across the world – you save and sustain lives. Thank you!
