Irish Red Cross delegates are typically seconded to the International Federation of Red Cross and Red Crescent Societies (IFRC) or the International Committee of the Red Cross (ICRC). Professionals living in Ireland and those living abroad who have a strong connection to Ireland can apply for the Irish Red Cross register. Only applicates who have the required skillset, as well as the general minimum requirements will be admitted to the register.

### **ROLE RESPONSIBLILTIES**

Due to the nature of emergency response operations, this role profile is an outline of the likely responsibilities applicable to a MHPSS Delegate deployed in a coordinated operation.

- Prevent distress and suffering from developing into something more severe
- Help people cope better and assist in resuming normal lives, install a sense of control over their situation and foster hope
- Utilise existing resources and structures in a community
- Contribute to a multi-layered emergency response ensuring integration of minimum standards for MHPSS and Protection, Gender and Inclusion across sectors
- Assess MHPSS needs, develop workplans, organize and conduct trainings, monitor project implementation, and ensure that strong monitoring & evaluation plans are in place for sound data collection, impact documentation and sharing of lessons learnt within the organization.
- Collaborate and coordinate with other RC/RC Movement, work closely with external MHPSS working groups and stakeholders.
- Advocate for the importance of integrating MHPSS and global protection minimum standards in a multi-sectorial setting.
- Link with Movement partners to develop adapted guidelines for protection and psychosocial support.
- Provide regular and timely reports following global standards.
- Engage and coordinate effectively with all groups as e.g. colleagues, men, women, girls and boys affected by the emergency, target beneficiaries, community leaders, National Governments and local mental health and psychosocial support actors
- Familiar with programme cycle and programme management tools Psychosocial technical competencies Mental health and psychosocial support
- Knowledge of psychosocial assessment, monitoring and evaluation tools
- Ability to analyse and recommend appropriate interventions
