# Irish Red Cross Data Protection Statement

# **Emergency Humanitarian Flooding Scheme**

Your privacy is important to us, and we are fully committed to keeping your personal information safe. This data protection statement is intended to provide you with information about the personal information we collect about you and how that information is used and shared. It also sets out your privacy rights. Please take a moment to familiarise yourself with our privacy practices so that you are fully aware of how and why we are using your personal data.

It is important for applicants to the Scheme to be aware that any funding granted under the Emergency Humanitarian Flooding Scheme is classified as State Aid.

From 1<sup>st</sup> January 2026, Ireland along with other EU member states will be obliged to record State aid and de minimis aid award data in a centralised European Commission database. This database will be called eAIR. The database is effectively an eAid Register and is part of enhanced mandatory transparency reporting requirements. Information on the Register will be publicly available. This means that eAIR will enable users to effectively search for and access comprehensive information on aid awards granted to beneficiaries of a Scheme (including the Emergency Humanitarian Flooding Scheme). Users will also be able to explore details such as the amounts awarded, the name and identifier of the beneficiaries, the aid instruments used and the relevant business sectors. Where the beneficiary is an individual (e.g. sole trader) a "masking" or pseudonymised version of the name of the individual or the unique identifying number will be applied to protect privacy rights.

#### 1. Data Controller

At the request of the Government, the **Irish Red Cross** has agreed to administer the **Emergency Humanitarian Flooding Scheme**. For the purposes of data protection laws, the **Irish Red Cross** in administering the Scheme is a **Joint Data Controller** with the **Department of Enterprise**, **Tourism and Employment (DETE)**. This means that we have certain responsibilities when we process or "use" your Personal Data. Part of these responsibilities include that we provide you with information about your personal data. This information is set out in this Data Protection Statement.

#### 2. Our Data Protection Officer

We have appointed a **Data Protection Officer**, **Mr. Marcus Keane** for you to contact if you have any questions regarding this data protection statement, our privacy practices or if you wish to exercise your data rights. #### 3. What is the Emergency Humanitarian Flooding Scheme?

The Emergency Humanitarian Flooding Scheme is an ad hoc Scheme and requires a specific Government Decision to be activated. In other words, the Scheme will only be activated if a flooding incident occurs and the Government decides to provide emergency funding to contribute towards the cost of returning Business premises and Community, Voluntary and Sporting Bodies to their pre-flood condition. The Scheme is targeted at Small Businesses with up to 20 employees (whole-time equivalents) and also includes Community, Voluntary and Sporting Bodies that have been affected by flooding and who could not secure flood insurance through any fault of their own.

The Scheme provides a once-off ex-gratia contribution towards the costs of returning business premises and community, voluntary and sporting bodies to their pre-flood condition, including for example, the replacement of flooring, fixtures, fittings, and damaged stock. The Scheme will not provide a contribution to loss of earnings, loss of business goodwill or for damage caused to pathways, outdoor arenas, carparks, etc.

#### **Eligibility Criteria**

#### **Scheme Administration**

While funding for the **Emergency Humanitarian Flooding Scheme** is provided by the **Department of Enterprise Tourism and Employment (DETE)**, the Scheme is **administered by the Irish Red Cross (IRC)**. The role of the Irish Red Cross is to advertise the Scheme, process applications received for funding under the Scheme, and check eligibility criteria by validating certain information with **Local Authorities** and in certain cases with **Claims Assessors** who are specifically appointed by the Irish Red Cross. Where an application for funding is approved and meets the appropriate eligibility checks, a payment will be made via electronic fund transfer (EFT) to qualifying Businesses, Community, Voluntary or Sporting Bodies.

# 4. Information we will collect in relation to the Emergency Humanitarian Flooding Scheme

The **Irish Red Cross** will obtain personal data from you when you complete the application form to apply for funding under the Scheme.

This will include the following data sets:

- > Applicant Name, Business/Trading name, Community, Voluntary or Sporting Body name
- > Business/premises address including eircode
- > Contact details (e-mail address and phone number)
- > Bank Account details
- > Tax Registration Number
- > Tax Clearance Certificate
- > Insurance Details
- > Business Category
- > Business, Community, Voluntary or Sporting Body Legal Status
- > Registered Charity Number (RCN) where applicable
- > Total number of employees / directors / owners
- Signature

The Irish Red Cross will also share certain financial information (amount of monies received under a claim) and other information with the Department of Enterprise, Tourism and Employment (DETE). This information will be used to ensure that the Department is meeting its obligations in complying with State Aid Rules (de minimis aid) and for reporting and auditing requirements. It is important to note that this information may also be used for future auditing of the monies provided to you from the Emergency Humanitarian Flooding Scheme. Where an overpayment or ineligible payment has occurred based on false or misleading information, this process will involve the recovery of monies and may be subject to criminal sanctions.

Other information, including your Personal Data may be shared with **Claim Assessors** working on behalf of the **Irish Red Cross** depending on the amount of funding you have applied for under the Scheme, and with the **Local Authorities** (**LA's**) in your area who will be involved in claim validation processes.

From 01<sup>st</sup> January 2026, certain data sets will also be required to be published in the new European Commission eAid database (known as eAIR) to meet mandatory EU wide transparency reporting requirements. Information on the eAid Register is set out at the start of this Data Protection Statement and further information can be found at: eAidRegister and De Minimus - European Commission.

#### 5. Why are we using your personal data?

The **Irish Red Cross** will use the information, including personal data you have provided on your application form to administer the **Emergency Humanitarian Flooding Scheme** on behalf of the **Department of Enterprise**, **Tourism and Employment (DETE)**. This information will be used to process your application form to see if you qualify for funding under the Scheme. In certain cases, we will also

provide information to **Claim Assessors** that we have appointed to validate your damage claim depending on the amount of the contribution you are claiming under the Scheme. Information will also be provided to the **Department of Enterprise**, **Tourism and Employment (DETE)** to meet statutory reporting and Scheme reporting and auditing requirements. In addition, your personal data will also be provided to **Local Authorities (LA's)** in your area who will be involved in claim validation processes. From 01<sup>st</sup> January 2026, information will also be provided by granting authorities to the new eAIR database (eAid Register) to meet EU wide mandatory transparency reporting requirements. The information on the eAir database will be publicly available.

#### 6. What is our legal basis for using your personal data?

We are required by data protection law to indicate to you the legal basis which relates to our use of your personal data. These are (as relevant):

• Article 6(1)(e) <u>GDPR</u> - processing is necessary for the **performance of a task carried out in the public interest** or in the **exercise in official authority vested in the Controller** (in this case the Controller is the **Irish Red Cross**) - section 5(1) of the Red Cross Acts, 1938 to 1954 and section 38 (1)(b) of the Data Protection Act, 2018.

#### 7. Who has access to the data?

Staff in the **Irish Red Cross** with responsibility for administering the Emergency Humanitarian Flooding Scheme. We are also required to share certain data sets with the **Department of Enterprise**, **Tourism and Employment (DETE)** for reporting and auditing purposes. The source of this information will originate from the details that you provided on the Emergency Humanitarian Flooding Scheme application form. It is important to note that any overpayments or payments made in relation to inaccurate or false claims will be recouped and may be subject to criminal sanctions.

Data provided on your application form may also be shared with relevant **Local Authority(ies)** in your area and **Claim Assessors** appointed by the Irish Red Cross to assist with the processing and validation of your claim.

From 01<sup>st</sup> January 2026, information will also be provided by granting authorities to the new eAIR database (eAid Register) to meet EU wide mandatory transparency reporting requirements. The information on the eAIR database will be publicly available.

Your personal data may also be shared by us with third parties to meet our legal obligations (including audit requirements), applicable regulation or other lawful requests.

#### 8. Data storage and retention

We will not retain or use your personal information for any longer than is necessary.

Your data will only be retained for as long as it is needed to fulfil the purposes of the Emergency Humanitarian Flooding Scheme and for a period of up to **10 years from the date of the closure of the Scheme** in order to comply with legal and regulatory requirements. (State Aid reporting requires us to retain certain information for 10 years).

Information on the eAid Register (eAIR database) will be publicly available for a period of 3 years but will be retained by the European Commission for a period of 10 years.

#### 9. International transfers

We do not transfer your personal data outside the **European Economic Area** (EEA).

#### 10. Your data rights

You have certain rights under data-protection law in relation to how we use your personal information. You have the right, free of charge, to:

- Request a **copy** of the personal information we hold about you. You can do this by contacting our Data Protection Officer at: <a href="mailto:dpo@redcross.ie">dpo@redcross.ie</a>.
- **Rectify** any **inaccurate** personal information we hold about you. If your personal data is incomplete, you have the right to have data completed, including by means of providing supplementary information.
- **Restrict** processing of your personal information in certain limited circumstances (e.g. if you have contested the accuracy of your personal data, for a period enabling us to verify accuracy).
- Not be subject to a decision which is based solely on **automated processing** where that decision produces a legal effect on you or otherwise significantly affects you. We do not make automated decisions of this nature.

We may take measures to verify your identity. We will do this by reference to copies of acceptable identification documentation supplied by you.

#### 11. Making a complaint
